In the event of a tie, the first tiebreaker will be total marks scored, second tiebreaker will be total marks allowed. If necessary, the third tiebreaker will be a one-game playoff.

We will play six games in the morning and four games after lunch. Games will be limited to 20 minutes or seven marks, whichever comes first. Coffee and donuts will be provided in the morning for tournament players, additional food and drinks may be purchased throughout the day from one of the many festival vendors in the nearby city square. We will break for lunch from 11:30 to 1:00 p.m., allowing ample time to eat and enjoy the Texas Blueberry Festival. Tournament play resumes promptly at 1:00 p.m. Any teams returning late from lunch will forfeit any games missed but will still be eligible to play in any remaining subsequent games.
