Enclosed is an application form so that you can sign up **as soon as possible**. **Please note** that there is a flat fee of **\$100.00 per booth space for non-food vendors** and **\$140.00 per booth space for food vendors**. There will be one check-in point for vendors the morning of the festival. **If you sign up by April 1st, we can make sure you are given the same booth space as you had in 2006!**

Please let us know your electrical requirements, the dimensions of your booth, and what you will be selling/displaying. **You must tell us all of the above on the application.** The Texas Blueberry Festival reserves the right to refuse any vendor that sells/displays something that was not listed on the original application.

NOTE THAT A CANCELLATION POLICY IS NOW SPECIFIED ON THE APPLICATION. We will also have a "Festival Contact Number" for possible relocation information in case of rain. As always, we will have shuttles to parking, and we will mail you more information about check-in and other details closer to the event.

Please respond by May 14, 2007 to secure your space(s). (Note: We have sold out early almost every year! **Don't Delay!**)

LITTER ABATEMENT DURING FESTIVAL

City Festival Guidelines (revised by the city commission on January 17, 2005) requires each vendor to provide one litter container for the general public to use during the festival. *Keep Nacogdoches Beautiful* volunteers will assist with litter removal from public areas throughout the festival (including public litter containers). Vendors are solely responsible for "back-door" litter created. For example, large boxes and packing material must be taken to dumpsters by vendors. Cooking oil and other food waste must be disposed of by the vendor. Please do not put your vendor litter in the receptacles provided for the general public. Dumpsters will be provided for vendors in several convenient zones throughout the festival area. Maps of their locations will be distributed at check-in.
